Office of the Municipal Executive, Pyuthan (OME Pyuthan) has received grant from **GON** for construction Bijuwar Mitramani chowk to Administrative Building of Pyuthan Municipality Premix carpeting pavement Road Phase III, Jhimruk River Training Work PhaseIII, Satamuni-Aplapata Badachaur-Amare Rural road Improvement Project, Tikiuri-Gurung gaun-lamchhayang Rural road Improvement Project and Kholi gaun -lamchhyang-Rural Road Improvement Project and OME Pyuthan intends to apply the funds to cover eligible payments under the contract for construction of works and further OME Pyuthan allocates fund. Bidding is open to all eligible Nepalese Bidders.
