Office of the Municipal Executive, Pyuthan (OME Pyuthan) has received grant from GON for construction Bijuwar Mitramani chowk to Administrative Building of Pyuthan Municipality Premix carpeting pavement Road Extension , Jhimruk River Training Work (Tikuri buspark), Kharibot-Majuwa-Thulasim -Chundarikhola -chucha Rural Road mantainance Project, Gejbang-Managau-Lamchayangneta Rural Road maintenance Project, Jumri Stream Training works &Jhimruk River Training works (Damti Area) and OME Pyuthan intends to apply the funds to cover eligible payments under the contract for construction of works and further OME Pyuthan allocates fund. Bidding is open to all eligible Nepalese Bidders.

Documents received after deadline will not be accepted.

The bids will be opened physically and electronically in the presence of Bidders' representatives who choose to attend at **14:00 hrs** on **2075/02/23 .Inc case of Contract no. 11, 13&14 Bid should be opened at 14:00hrs On 2075/02/08** at OME, Pyuthan Bijuwar. Bids must be valid for a period of 90 days after the deadline for bid submission date and must be accompanied by minimum bid security amount listed below, which shall be valid for 30 days beyond the bid validity period. In case of Contract no 11,14,&15 Bid must

be valid For a **period of 75 days after** the deadline for bid submission date & must be accompanied by minimum bid security amount listed below, which shall be valid for 30 days beyond the bid validity period.

8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
